From Sacramento Area: I-80 West to CA-12/Jameson Canyon Rd, toward Napa/Sonoma. Turn right at CA-12/CA29/Napa Vallejo Hwy. Slight right toward CA-221/Napa Vallejo Hwy (signs for Downtown Napa). Slight right at CA-221/Napa Vallejo Hwy. Slight right at CA-121/Silverado Trail. Turn left at Third Street.

From San Francisco Area: I-80 East. Take exit 33 to merge onto CA-37 W toward Napa. Take exit 19 for CA-29 toward Napa/Downtown Vallejo. Turn right at CA-29/Sonoma Blvd (signs for CA-29/Napa) and continue to follow CA-29. Slight right toward CA-221/Napa Vallejo Hwy (signs for Downtown Napa). Slight right at CA-221/Napa Vallejo Hwy. Slight right at CA121/Silverado Trail. Turn left at Third Street.

From Santa Rosa Area: US 101 South (toward SF). Take CA-116 exit toward Sonoma/Napa. Turn left at CA-116/Lakeville St. Turn left at CA-116/ Stage Gulch Rd. Turn right to stay on CA-116-Stage Gulch Rd. Continue to follow CA-116. Turn left at CA-121/Fremont Dr. Continue to follow CA-121. Turn left at CA-121 N/CA-29 N. Exit onto CA-121/CA/W Imola Ave. Turn left at CA-121/CA221/Soscol Ave. Slight right at CA121/Silverado Trail. Turn left at Third St.

MATCH RULES:

CONFORMATION: Puppies will not compete with adults. A puppy must enter either as a puppy OR adult, but not both. No major pointed dogs. No ear tapes in the ring. Professional handlers may show their own dogs. All dogs must be registered with the AKC.

CLASSES: PUPPIES – 4-6 months, 6-9 months, 9-12 months, 12-18 months, conformation (divided by variety and sex). ADULTS – 18 months and over.

SPECIAL CLASS / VETERANS: 7 – 9 years or Over 9 years.

FEES: Early entry fee taken no later than November 1, 2011 is \$6.00. Fee after November 1, 2011 is \$8.00. Special Class / Veterans – fee \$8.00. Parade of Champions – fee \$8.00. Rescue Parade – free. Entries will be taken day of show from 10:30 a.m. – 11:00 a.m. **Judging start TBD.**
